 - **Colors and background colors can be adjusted.**
 - *The materials can be downloaded in PDF format to allow students to change font and background colors using a third party application.*
- **Background: High contrast color settings are available.**
 - *The materials can be downloaded in PDF format to allow students to adjust contrast using a third party application.*
 - **Text-to-speech tools**
 - *The materials can be downloaded in PDF format allowing students to access text-to-speech tools using a third party application.*
 - **All images have alt tags.**
 - *The digital materials do not contain alt tags.*
 - **All videos are captioned.**
 - *Some ancillary videos we provide are not captioned.*
 - **Text, image tags, and captioning sent to refreshable Braille displays.**
 - *The materials can be downloaded in PDF format allowing students to access the materials using refreshable Braille displays.*
